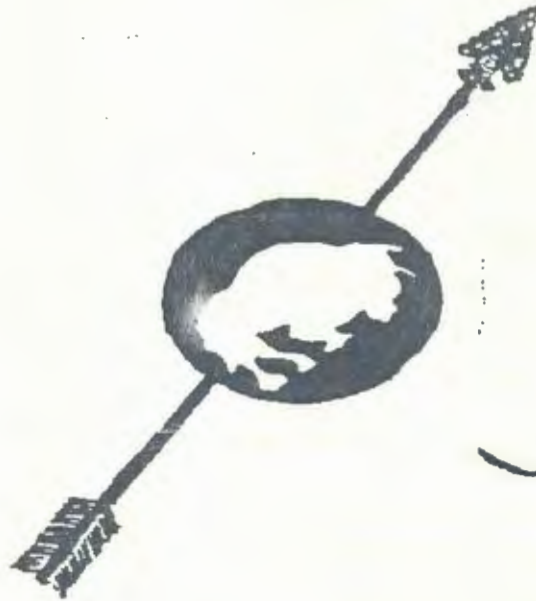

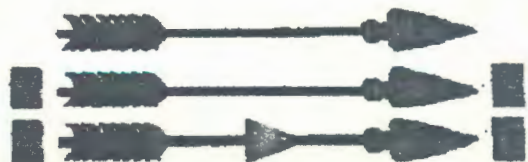
CONCLAVE
